In participating in this event, the undersigned acknowledges that this is not a race or speed competition and that each individual is responsible for their own personal safety as well as the safety of occupants of their watercraft. All registrants agree to act in a reasonably prudent manner, including, but not limited to, refraining from operating a watercraft while impaired or under the influence of drugs or alcohol, maintaining a safe distance from other boaters, operating at a safe speed for the conditions, and keeping a proper lookout for other boaters, conditions, and hazards. It is further understood and acknowledged that the undersigned will abide by all federal, state, and/or local laws in the operation of any watercraft. It is acknowledged that the use of coast guard approved flotation devices and kill-switch lanyards are strongly encouraged during operation.
